4. Your rights

You have the right to:

- withdraw your consent at any time according to Art. 7 para. 3 GDPR. This results in the fact that I am no longer allowed to process data based on your consent in the future;
- obtain from me confirmation as to whether or not personal data concerning you are being processed, according to Art 15 GDPR. Particularly, you have the right to obtain information about the purposes of the processing; the categories of personal data concerned; the recipients or categories of recipient to whom the personal data have been or will be disclosed, the envisaged period for which the personal data will be stored, or, if not possible, the criteria used to determine that period; the existence of the right to request from me rectification or erasure of personal data or restriction of processing of personal data concerning the data subject or to object to such processing, lodge a complaint with a supervisory authority; where the personal data are not collected from the you, any available information as to their source, and about the existence of automated decision-making, including profiling and, in those cases, meaningful information about the logic involved, as well as the significance and the envisaged consequences of such processing;
- obtain from me without undue delay the rectification of inaccurate personal data concerning you, according to Art. 16 GDPR. Taking into account the purposes of the processing, you shall have the right to have incomplete personal data completed, including by means of providing a supplementary statement;
- to obtain from me the erasure of personal data concerning you without undue delay where the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed, for exercising the right of freedom of expression and information, and where there is no other legal ground for the processing, or for the establishment, exercise or defence of legal claims according to Art. 17 GDPR;
- obtain from me restriction of processing where the accuracy of the personal data is contested by you, the
 processing is unlawful, and you oppose the erasure of the personal data and requests the restriction of their use
 instead, I no longer need the personal data for the purposes of the processing, but they are required for the
 establishment, exercise or defence of legal claims, you have objected to processing pursuant to Art. 21 GDPR,
 according to Art. 18 GDPR;
- receive the personal data concerning you, which you have provided to me, in a structured, commonly used and
 machine-readable format and have the right to transmit those data to another controller, according to Art. 20
 GDPR; and
- lodge a complaint with a supervisory authority. You can do so at an authority of your habitual residence, place of work or place of my registered office, according to Art. 77 GDPR.

5. Right to object

In case your personal data are being processed on the basis of Art. 6 para. GDPR, you, according to Art. 21 GDPR, have the right to object based on grounds relating to your particular situation.
